## IN THE NAME OF THE KING!

THE GOVERNOR of Aruba,

Having considered:

- that, in the context of a uniform foreign policy of the Kingdom, as well as in the interests of the international legal order, it is desirable to supplement Annex I to the Interim State Decree on Priority Sanctions Regimes (AB 2019 No. 47) with a number of Regulations, Decisions and Common Positions, adopted within the framework of the Common Foreign and Security Policy of the European Union, insofar as they are intended to maintain or restore international peace and security;

Having regard to:

Articles 2 and 2a of the Sanctions State Ordinance 2006 (AB 2007 No. 24);

After hearing the Advisory Council, has decided:

## Article I

The Interim State Decree on Priority Sanctions Regimes (AB 2019 No. 47) shall be amended as follows:

A the following amendments shall be made to Article 1:

1. in the description of the term “Annex I”, “Regulations and Decisions” shall be replaced by: Regulations, Decisions and Common Positions.
2. in the description of the term “Regulations and Decisions”, the following shall be inserted after the words “legal order”: as well as the Common Positions.

- B in Articles 2, first paragraph, 5, first paragraph and third paragraph, “Regulations and Decisions” shall each time be replaced by: Regulations, Decisions and Common Positions.
- C in Articles 4, first paragraph, and 5, first paragraph, a comma shall each time be placed after “legal person”, and “or other entity” shall be replaced by: entity or body.
- D in Article 5, third paragraph, “persons,” shall be replaced by: natural persons, legal persons.
- E Annex I shall be replaced by Annex I to this State Decree.

## Article II

This State Decree shall enter into force as of the day following the day of its publication in the Official Bulletin of Aruba.
