STATE DECREE containing general administrative orders of April 1, 2022 implementing Articles 2 and 2a of the Sanctions Ordinance 2006 (“AB” [*Official Bulletin*] 2007, No. 24) (Sanctions State Decree Territorial Integrity Ukraine I)

IN THE NAME OF THE KING!

THE GOVERNOR of Aruba,

Having considered:

that, in the interest of international legal order and the foreign policy of the Kingdom, it is desirable to implement without delay Regulation (EU) No. 2022/334 of the Council of the European Union of February 28, 2022 amending Regulation (EU) No. 833/2014 and Decision (CFSP) 2022/335 of the Council of the European Union of February 28, 2022 amending Decision 2014/512/CFSP concerning restrictive measures in view of Russia's actions destabilizing the situation in Ukraine;

Having regard to:

Articles 2 and 2a of the Sanctions State Ordinance 2006 (AB 2007 No. 24);

Has decided:

Article 1

1. Transactions related to the management of reserves and of assets of the Central Bank of Russia, including transactions with legal persons, entities or bodies acting on behalf of, or at the direction of, the Central Bank of Russia shall be prohibited.
2. It shall be prohibited to participate in activities the object or effect of which is to circumvent directly or indirectly the measures referred to in the first paragraph.

Article 2

1. It shall be prohibited to give any aircraft operated by Russian air carriers, including as a marketing carrier in code-sharing or blocked-space arrangements, any aircraft registered in Russia and any aircraft

not registered in Russia which are owned or chartered, or otherwise controlled by Russian natural or legal persons, entities or bodies, permission to land in, take off from or overfly the territory of Aruba.

2. The prohibition referred to in the first paragraph shall not apply in the case of an emergency landing or an emergency overflight.
3. Notwithstanding the first paragraph, the competent aviation authority may authorize an aircraft to land in, take off from or overfly the territory of Aruba if such aviation authority has determined that such landing, take-off or overflight is required for humanitarian reasons or for any other reason consistent with the objectives of this State Decree.

Article 3

1. This State Decree shall enter into force as of the day following the day of its publication in the Official Bulletin of Aruba.
2. It may be cited as Sanctions State Decree Territorial Integrity Ukraine I.
