BUSINESS SENTIMENTS MORE OPTIMISTIC IN THE FOURTH QUARTER OF 2022

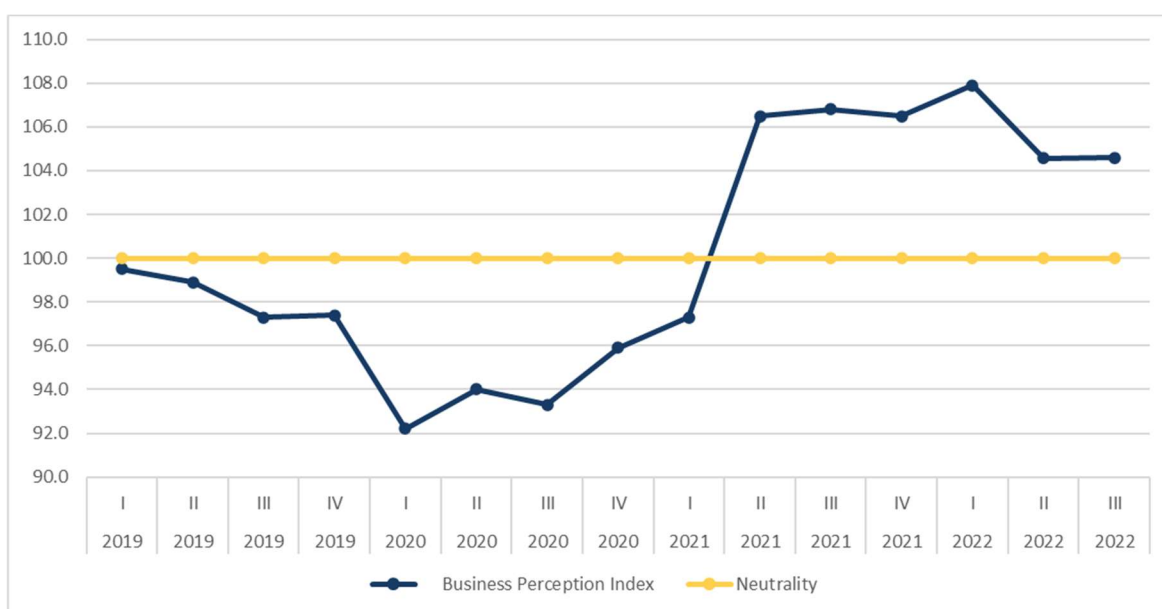

Results for the fourth quarter of 2022

The Central Bank of Aruba (CBA) concluded its Business Perception Survey (BPS) for the fourth quarter of 2022. The BPS assesses the economic sentiments of local businesses.

In the fourth quarter of 2022, the Business Perception Index (BPI), comprising the current and short-term economic conditions, strengthened to 105.2. This outcome resulted from an increase in the current economic conditions index, while the short-term economic conditions index reported a decrease (See Chart 1)¹.

Chart 1: Business Perception Index

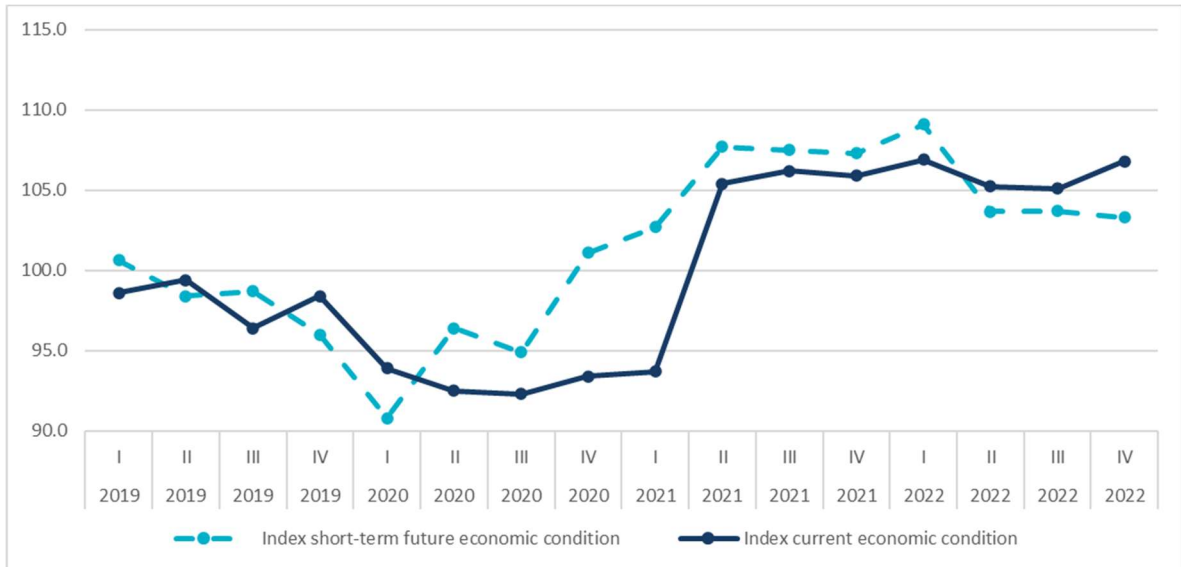

The current economic condition index edged up by 1.7 index points to 106.8, up from 105.1 in the third quarter of 2022. The short-term future economic condition index dropped to 103.3 in the fourth quarter of 2022 (See Chart 2). The percentage of respondents expecting positive economic growth in the next 12 months decreased slightly by 0.1 percentage point to 43.8 percent.

¹ The index can vary between 90 and 110. Between 90 and 100 indicates a situation of pessimism. An index of exactly 100 indicates that businesses are neither pessimistic nor optimistic but are neutral with regard to their thoughts about economic developments in Aruba. Between 100 and 110 indicates a situation of optimism in business sentiments.
